Regular Scheduled Church Conference March 12, 2023

The Moderator – Steve Ray called the church into conference and opened with prayer.

Minutes from the January 15, 2023 conference was reviewed and accepted as presented.

A. Committee Reports

1. Financial Committee - Paul Summerville

YTD Regular Offerings: \$628K --> \$6K under budget (1%)
YTD Operational Expenses: \$589K -->\$47K Under budget (7%)

YTD Designated Funds for Loan Payment Received: \$29K

Cash YTD

On a cash basis, we have received \$628K and spent \$589K.

Month to Month

Our Cash balance decreased by 29K from January to February.

Unrestricted Cash Balance: \$398K (4 months reserve) @\$98K/Month

average spend

Designated Cash Balance: \$237K

Total Cash Balance: \$636K

Other Relevant Balances

Loan Balance: \$17K – decrease of \$12K -- > Previous balance 29K

Fixed Assets: \$4,911K – no change

Conclusion:

The Year-to-date Offerings to Operational Expenses gap has finally closed as areas have again deferred spending to allow for the offerings to catch up. Through 6 months of the FY we have now brought in more than we have spent.

A question was raised in the January church conference regarding the YTD Designated Funds for Loan Payment. As a reminder, the church has put in the budget to pay the loan from budgeted funds. Any additional amount that comes in specifically for the Loan payment is added to that regular payment and goes directly towards principal. Through the first 6

months of the FY, we have received 29K specifically for the loan payment. So, as you see the Month-to-Month loan balance decrease by 12K, that is the regular loan payment(9K) + whatever was given in February for the loan (roughly 3K). It is our expectation, with the Lord's blessing that we will pay 9K from the March payment + any additional amount received designated for the loan. The final payoff amount will occur in April 2023 and South Point Baptist will be debt free!

The Total Cash balance decrease was predominantly caused by a reduction in designated funds for the allocated amounts for the Pomeroy Eagle Scout Project and the amount sent to the Baptist State Convention for Lottie Moon.

We are still in a very blessed position, thanks to God and the blessings of His church.

The financial reports were accepted as presented.

2. Committee Reports

Building and Grounds – Mike Phillips

Getting an estimate to extend the new fence around the playground to go in front of the basketball court to keep people from parking on the court as it will damage the surface.

Also getting an estimate to install a fence on the side next to the trees, to keep the basketball contained and not having it go into the wooded area and down the hill.

Once we have the estimates, we will advise the church of the cost.

B. Old Business

a. Wednesday night meals

There was much discussion in regards to the challenges regarding restarting these meals.

- Pastor Mike Phillips has had discussions with the current kitchen crew and they do not feel that they are able to take on these additional responsibilities.
- A suggestion was made that we engage the different Sunday School classes and see if several classes would be willing to have a group from each class volunteer to handle the meal each week, breaking the responsibility into several groups.

• Kathy Howard (who is a member of the kitchen crew) spoke that the work required to have these weekly meals is significant, and the members of the current kitchen crew are reaching the point in their life where they can no longer provide this service. The same people have been doing this for 10 years (or longer) and due to their age, it is becoming too much of a burden. Today, they continue to prepare meals for several different functions (Starting Point Class, The Least of These (monthly), and for various other events) and that is about all they can handle.

Kathy was not enthusiastic about having different groups handle the meals as there are certain things that must be done to ensure that the kitchen is left is good order, and that becomes difficult if multiple groups are involved. She suggested getting 12 younger people who can make the weekly commitment, and use just one group to handle these meals.

- Mike Phillips asked if there might be a better way to use our resources to impact our community through ministry or missions.
- Alicia Green said that the fellowship part of this was important to her, and used an example of how she got to know people in the church who were not in her circle (i.e. age group or SS Class), but she got to know many people that she, otherwise would have not had an opportunity to engage with.
- Jerry Harris noted that the work required to get the food, prepare the food, clean up, etc was daunting and required a lot of time, as he and Robin went and bought the food for many years, and his wife, Debbie headed up this effort. So he spoke from first hand experience that this requires a huge commitment.
- Bob Deaton asked that it be put into the minutes that the church extend a warm "Thank You" to those who have served faithfully in this kitchen ministry for all these years, and the church agreed.
- Steve Ray recommended that we try to determine the overall interest, and Tod suggested that possibly we survey our membership to gauge both the interest in having these

Special Called Conference to discuss the search for our Worship Pastor

Moderator Steve Ray called the church into conference and opened with prayer.

Steve recognized Amber Summerville, Chair of the Worship Pastor Search Team to present a motion before the church. The motion is as follows:

The Worship Pastor Search Committee is requesting authorization to enter into a contract with Dwight Whitworth & Company, using their service to search out suitable candidates for the position of Worship Pastor.

Mike Phillips provided additional detail and background information. He noted that over the past weeks, that we have had several resumes, but almost all are from candidates who are not currently serving in a church. Most did not fit the criteria (experience, education, etc.) we have for our position. Mike noted that we have received only one resume that merited attention, and upon examination the candidate was quickly eliminated as a viable candidate. He described our current situation as a "resume drought". Amber Summerville mentioned that we have had candidates to apply via our website, and when the committee reached out to them, the committee received no response at all.

It has become evident that candidates looking to move to a new church are using specialized search firms to pair them with the right church. By using a search firm, the candidate can keep their search confidential, as opposed to posting their resumes on traditional association related websites.

It has become clearly evident that if we are to find a suitable candidate, we are going to have to use a search firm.

Our committee has engaged in very preliminary discussions with Dwight Whitworth & Company ("DWC") who specializes in this area, working only with churches, to pair the right candidate with the right church.

The committee has met with a representative of DWC, and after the meeting, felt very comfortable that DWC is the firm that we should partner with. As a confirmation of this, a sister church in Gastonia has used another firm, without success, then switched to DWC and found a candidate for their Worship Pastor position. The owner of DWC is Dwight Whitworth who was raised in McAdenville. One consultant is familiar with South Point and known and trusted by a couple of church members.

DWC is confident that they can have the first candidate for our search committee to look at in 6-8 weeks. If, in the opinion of our Pastor and the committee, that this candidate is not a good fit, then DWC will present a 2nd candidate. This process will continue until our Pastor and Committee feel confident that we have the right candidate for our church.

The process that DWC employs will include a visit to our church, to observe, talk with staff and our committee so that they get a good feel for our church and the type of candidate we are looking for.

They have a thorough vetting process for all candidates that will be presented including a thorough background and reference check.

When our previous Worship Pastor left, we kept the salary for that position in our budget. The cost to use DWC week to week will not exceed the amount already in our budget. The initial administrative cost (\$3500) and the observation and pilot weekends should not exceed the budget though it is possible to have some additional costs.

The floor was then open to questions. Many questions were asked, and all were answered by the Pastor along with various committee members.

When no further questions remained, the motion was reread.

The Worship Pastor Search Committee is requesting authorization to enter into a contract with Dwight Whitworth & Company, using their service to search out suitable candidates for the position of Worship Pastor.

A vote was taken, and the motion was unanimously approved.

With no further business, Kevin Joyce entered a motion to dismiss with a second by Greg Keistler.

Kevin Joyce closed with prayer.
