Regular Scheduled Church Conference November 12, 2023

The Moderator Steve Ray called the church into conference and opened with prayer.

Minutes from the September 17th conference was reviewed and accepted as presented.

1. <u>Committee Reports</u>

a. Financial Committee – Paul Summerville

Cash YTD

On a cash basis, we have received \$174K and spent \$202K.

Month to Month

Our Cash balance decreased by 35K from September to October.

Unrestricted Cash Balance: \$458K (4.5 **months reserve**) @\$101K/Month average spend Designated Cash Balance: \$270K

Total Cash Balance: \$729K

Other Relevant Balances

Fixed Assets: \$4,911K – no change

Conclusion:

Second month of the FY, we are under budget in both receipts and expenses. In October we spent more than we have received. Of the 35K cash balance decrease, most of this was driven by the Building and Grounds ministry in Building Improvements and Parking lot maintenance projects. Much of this was budgeted for the year, however these amounts hitting the budget so early in the FY is what is causing it to look off. Also, giving would have previously kept pace with expenses, to offset the amount leaving the account. In this FY this has not been the case.

One bright spot to note, is that we were able to move money from the checking account to the money market account which is earning higher interest. In the previous month, we were able to earn close to \$2600 in interest.

The financial report was accepted as presented.

1. Old Business

Pastor Mike gave update on the Worship Pastor search. The lead consultant with the search firm has been replaced with the owner of the firm, Dwight -----. Pastor Mike shared that an initial meeting with a proposed candidate is being pursued by the Search Committee. A guest Worship Leader is coming in December to lead us but this isn't our selected Worship Leader.

Pastor Mike gave an update on the idea to live stream our services. There will need to be a designated room identified that will house the equipment needed for mixing and producing the live stream. The current storage room in the choir room may serve as that designated room, provided modifications to the room are performed. The estimated cost for construction, electrical upgrades, video equipment and software are approximately \$8,700. Additional camera and lighting would be necessary to produce a quality live stream video.

Questions were asked as to why we need a live stream of our services and the answer were multifactual.

First, Pastor Mike recognized that a quality live stream would be necessary to present the Gospel to the viewers and to attract them to our church

Second, understanding that our current consumer culture video previews venues prior to visiting.

Third, there are personal security benefits of having a live stream of our services. Those benefits are understood by our Security Team.

Pastor Mike asked if the will of the Church was to pursue a cost proposal for live streaming? The Church in attendance of the conference agreed to that direction. Expected delivery of that proposal will be at our next Church Conference in January.

Special Called Church Conference January 7th, 2024 6:00 PM

1. Steve Ray called the church into conference and opened with prayer.

Steve advised those in attendance that this Special Called Church Conference was called for the purpose of reporting out of the report of the Worship Minister Search Committee. Steve recognized Amber Summerville, chairperson of the search committee.

1. Amber recognized each member of the search committee and thanked them for their service.

Amber shared that the committee had selected a candidate from the list of four candidates provided to the committee by DWC, (the Church hired search company).

- 2. Amber announced that Mr. Alex Bowers was chosen as the committee's candidate to serve as South Point Baptist's Worship Minister.
- 3. Amber and each member of the committee shared their personal comments for why they selected Mr. Bowers as the best candidate for the position. Mr. Bowers' talents, skills and abilities were expounded on by each committee member, with a common thread being his demonstrated musical knowledge and his spiritual maturity that was well beyond his 23 years.
- 4. Amber shared that she has previous personal knowledge of the Bowers family while visiting Flint Groves Baptist where Alex's father serves as senior pastor.
- 5. Amber shared that Mr. Bowers was a graduate of North Gaston High School, receiving his Bachelor of Arts in Christian Ministry degree from North Greenville University
- 6. Mr. Bowers has served as visiting Worship Leader in our church twice this fall
- 7. Pastor Mike announced the recommendation for the salary package of \$62,000, which would be within the budget.
- 8. The floor was opened to questions. Much discussion ensued, good questions were asked, committee members and pastor Mike answered these questions.
- 9. The candidate will be available to our church for a meet and greet opportunity Saturday January 13th from 10:00 to 11:00 am. The candidate will serve as our Worship Leader Sunday morning January 14th. Afterwards the church will vote to accept the candidate for the position of Worship Leader.
- 10. After all questions were addressed, a motion was made by Robin Buchanan, seconded by Greg Keistler to close the conference.
- 11. Steve asked for continued prayer for the candidate during this process.
- 12. Pastor Mike closed the meeting with prayer.
