On a cash basis, we have received \$355K and have spent \$376K.

Month to Month

Our Cash balance increased by 40K from November to December. Mostly attributed to the Lottie Moon increase in Designated funds.

Unrestricted Cash Balance: \$470K (4.9 months reserve) @\$94K/Month average spend

Designated Cash Balance: \$307K

Total Cash Balance: \$777K

Other Relevant Balances

Fixed Assets: \$4,911K - no change

Conclusion:

Fourth month of the FY, we are under budget in both receipts and expenses. Through December we spent more than we have received. This was discussed in the previous budget reading as the projects we had budgeted for in this FY were completed up front. We would expect giving to catch up and normalize with expenses.

Since we moved more money from Checking to Money Market, we have been able to gain close to \$9200 in interest.

The financial report was accepted as presented.
